  5. Vendors should be present at the Venue no later than 9 am on event day to setup their Booth.

Food Vendors must comply with all applicable Fire, Safety, Health and other applicable codes and regulations, and will be responsible for obtaining any necessary permits required by any of the local government authorities in each venue where the Event will be held. No Refund will be issued if the Vendor cannot get the necessary permits on time.
  7. No Vendor will be allowed to display/sell or setup its booth until Full Payment is made.
  8. Intense 102.9 FM reserves its right to deny any applicant(s).
  9. All vendors must stop sale at 7pm Sharp and vacate the Booth by 8 pm (otherwise fine will be charged by facility).
