1. Vendors will be responsible for their liability insurance and in compliance with licensing, State and Local Laws.
2. Vendors are NOT allowed to distribute FREE samples or any FREE drinks.
3. Vendors can only sell items listed on page 1.
4. Vendors can only display their banners or any marketing material within their Booth.
5. Vendors should be present at the Venue by 9am on the day of the event to setup their Booth.
6. Food Vendors must comply with all applicable Fire, Safety, Health and other applicable codes and regulations, and will be responsible for obtaining any necessary permits required by the county. No Refund will be issued if the Vendor cannot get the necessary permits on time. For more details please visit this link

7. All vendors must clean their BOOTH before leaving the venue, all trash should be placed in the Trash Dumpsters kept outside. A penalty of \$100.00 will be charged if the Booth is left untidy.
8. Each Non-Food vendor will get, a 10 x 10 Tent, 1 Table, 2 chairs and 2 Entry Bands with each Booth. Food vendors will get a 10 x 20 Tent, 4 Tables, 4 Chairs and 6 Entry Bands. Additional table, chairs and Entry Bands can be given by paying additional charges.
9. IntenseDMV holds the right to refuse a Vendor for participating in the Event if they do not follow these terms and conditions. At such time all money paid by the Vendor will be forfeited.
10. Terms and conditions are subject to change without notice.
11. This is a rain or shine event. All sales are final and there is NO REFUND due to bad weather or any other reason. All transactions are final and Non-Refundable.
12. We don't provide electricity, if you need, you can get your own generators.
13. Vendor will NOT be allowed to display/sell or setup their booth until Full Payment is made.
